## **AASC CHARITY/SERVICE PROJECT RECOGNITION APPLICATION FORM**

### **RATIONALE:**

In an effort to recognize all the outstanding Charitable Contributions and Service Projects that our Member Schools are conducting the AASC Executive Board has authorized this award program so that any AASC member school that applies may be recognized at the annual AASC State Convention for their honorable efforts in these areas.

### **LEVEL OF RECOGNITION AND REQUIREMENTS:**

#### **Bronze Level:**

For AASC Member Student Councils that have engaged in the following:

- A) Raising Charitable Contributions or performed Service Projects that range in the dollar amount of \$1.00 to \$500.00
- B) Have engaged in Service Projects that range in time from 5 hours to 50 (as a group) in hours for service time performed.

#### **Silver Level:**

For AASC Member Student Councils that have engaged in the following:

- A) Raising Charitable Contributions or performed Service Projects that range in the dollar amount of \$501.00 - \$1000.00
- B) Have engaged in Service Projects that range in time from 51 hours to 150 (as a group) in hours for service time performed.

#### **Gold Level:**

For AASC Member Student Councils that have engaged in the following:

- A) Raising Charitable Contributions or performed Service Projects that range in the dollar amount of more than \$1000.00
- B) Have engaged in Service Projects that range in time more than 150 (as a group) in hours for service time performed.

### **ADDITIONAL REQUIREMENTS:**

The following are required for all levels (bronze, silver, & gold) of recognition.

- 1.) In no less than 250 words but no more than 400 words, please send a type written description that outlines the nature of your Charitable Contribution or your Service Project. The description should include the date, time and location and who or what group benefited from your assistance.
- 2.) To be eligible for this recognition, please include written documentation from the Charitable organization or the benefactor of the Service Project that your Student Council assisted. Schools seeking this recognition may instead secure a letter from your school's Administration affirming the work that your Student Council has done in these two areas. Please make certain that this documentation clearly states the amount achieved.
  - CHARITABLE CONTRIBUTION (Bronze = \$1 - \$500 / Silver \$501 - \$1000 / Gold \$1000 +)
  - SERVICE PROJECT HOURS (Bronze = 5 Hrs. – 50 Hrs. / Silver 51 Hrs. – 150 Hrs. / Gold 150 Hrs +)
- 3.) Schools seeking this recognition must submit a minimum of **three** photographs as further verification that the charitable contribution or service project has taken place.
